DUE TO LIMITED SPACE, UNENTERED DOGS MAY NOT BE IN THE FREE GROOMING AREA OF THE SHOW SITE.

Dogs must be ready for judging. Neither the Club nor its Show Chairman will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. Owners or agents are responsible for their dog's presence in the judging ring. Dogs need be present only for scheduled judging and will be released if not needed for further judging.
