#### **DIRECTIONS TO SHOW**

## Mercer County Park West Windsor Township, New Jersey

From North & South Via Intestate 295: Take 295 to Exit 65A, Sloane Avenue. East on Sloane Avenue to Second traffic light, Quaker Bridge Road. Cross over Quaker Bridge Road and go to next traffic light (road makes a T) at Old Trenton/Edinburg Road (Route 535). Turn left onto Old Trenton/Edinburg Road, Mercer County park is about two miles ahead on left.

From North Via U.S. 1: Take US 1 South of Princeton to Rt. 533, Quaker Bridge Road. Bear Right off US 1 into Jughandle and cross over US 1 onto Rt. 533, Quaker Bridge Road. Travel 2.4 miles and turn left onto Youngs Road and veer right on to Hughes Drive. At the first traffic light, turn left onto Old Trenton/Edinburg Road. Route 535. Travel about 1.5 miles on Route 535 to the exhibitors' entrance to the Park on the left.

**From South Via U.S. Route 1**: Cross toll bridge into New Jersey. On U.S. 1 make first right past Quaker Bridge Mall onto Quaker Bridge Road (Route 533). Travel 2.4 miles and turn left onto Youngs Road and veer right on to Hughes Drive . Make left at traffic light onto Old Trenton/Edinburg Road (Route 535) and proceed to the exhibitor's entrance about 1.65 miles on left.

**From North (Route 130S) Turnpike Exit 8 A:** Exit 8 A toward Rt. 130 South. Go to the 6th light and turn right onto Old Trenton Road (Rt. 535). Go through 6 traffic lights. MC Park is on right Just ahead.

From South Via NJ Route 130/206: Follow Route 130 North to Route 526 in Robbinsville. Turn left at traffic light onto Route 526. (Comers: Costal Delta Station, Russert's Deli). Turn right at the next traffic light; you are still on Route 526. From this point travel 3 miles to Route 535, Old Trenton/Edinburg Road and turn left. The exhibitor's entrance to the show grounds is about 1/3 miles ahead on the right side. From South Via New Jersey Turnpike: Take NJ Turnpike North to Exit 7A. Take Interstate 195 West to Exit 5B which is the first exit on Route 195 To Route 130 North, New Brunswick. Travel North on Route 130 to second traffic light and turn left onto Route 528. Proceed to the next traffic light and turn right (still Route 526). Follow signs. Go 3 miles to Route 535 and turn left. The park exhibitors' entrance is 1/3 miles ahead on the right.
