The owner or handler of each dog is solely responsible for having it ready at ringside when its class is to be judged. The show giving Club and Superintendent have no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required. Being an unbenched show, you need to be at show only in time for your judging and may leave any time after judging. Numbers before each represent the number of dogs entered in (1) the regular dog classes; (2) regular bitch classes; (3) Best of Breed; (4) Non-Regular classes.
